Currently zoned as R-2. Requesting A-2 zoning.

Dave presented a map from Kevin Kutscher, Watson Township Assessor, requesting a zoning change in a parcel from R-2 to A-2. Discussion. After discussion, led by Mark, Dave will talk to Kevin about changes. It really wouldn't be advisable to change it at this time, because of the rite to farm act. The rite to farm act means that farming is exempt from zoning. In R-2 you can have small lots and in A-2 you have larger lots.


